## The Role

We are seeking a proactive and experienced individual to join JOA's six-member governing board as a Non-States Commissioner in January 2025.

This is a voluntary, non-remunerated position, with an initial term of three years, which is renewable, subject to confirmation by the States Assembly.

As a Commissioner, you will help shape the strategic direction and governance of Jersey's international relief and development programme, joining a group of highly motivated volunteers.



## Key Responsibilities

#### Strategic Oversight

Collaborate with fellow Commissioners and the executive team to set and monitor JOA's strategic objectives, ensuring they align with the organisation's mission to support global development and humanitarian efforts.

#### Governance and Compliance

Uphold robust governance practices and ensure compliance with all regulatory and financial standards. Offer expert oversight to ensure the organisation's resources are deployed effectively and efficiently.

#### **Financial Oversight**

Leverage your experience in finance, governance, or compliance to provide guidance on financial planning, risk management, and the allocation of funds to emergency and development projects.

#### **Grant Application Review**

Review and evaluate grant applications for a range of emergency relief and development projects, ensuring funds are directed where they will have the most impact.

#### **Attend Monthly Meetings**

Participate in monthly board meetings and contribute to the strategic discussions that shape JOA's approach to global humanitarian relief.

#### Stakeholder Engagement

Build and maintain relationships with key stakeholders, including government, international partners, and donors, to enhance the effectiveness and outreach of JOA's mission.

#### **Promote JOA's Mission**

Serve as an ambassador for Jersey Overseas Aid, advocating for its values and objectives to diverse audiences, both locally and internationally.

## Key Skills & Experience

#### Finance & Governance Expertise

Proven experience in financial management, organisational governance, or regulatory compliance, ideally at a senior level.

Ability to offer strategic financial oversight, to ensure that resources are used efficiently and effectively.

#### Governance & Oversight

Strong understanding of governance principles and previous experience of ensuring organisations meet their legal and regulatory responsibilities.

#### **Proactive & Solution-Oriented**

A proactive and dynamic mindset, with the ability to identify risks and challenges and develop effective solutions.

Demonstrably highly motivated to have a positive impact on the effectiveness of the board and the direction of the organisation.

#### Commitment to Global Development

A demonstrable interest in overseas aid, humanitarian work, and sustainable development, supported by relevant professional or personal experience.

#### Relationship Building & Collaboration

Excellent interpersonal skills, with the ability to collaborate with a diverse range of stakeholders and foster strategic partnerships.

Ability to inspire and to communicate a shared vision while working effectively within a team.

#### **Desirable Experience**

Experience in governance, risk management or compliance within a charitable, non-profit, or international development organisation.

Familiarity with the management of public funds or similar financial accountability models.



## Terms of Appointment

This is a non-remunerated role.

You will serve an initial three-year term, which is renewable, subject to confirmation by the States Assembly.

The position requires Jersey residency.

By joining Jersey Overseas Aid, you will contribute to an internationally recognised organisation that is committed to making a significant impact on the lives of those most in need. If you have the experience, passion, and commitment to this role, we look forward to hearing from you.

### How to Apply

Applications should be made by submission of a full CV detailing your qualifications, employment skills, and experience. Please also include a covering letter of no more than two pages setting out your interest and highlighting the most relevant aspects of your background.

Please summarise the most significant contribution or impact that you have made at board level, what you believe you could bring to JOA as a Non-States Commissioner, and how you meet the person specification.

Please include the names and contact details of two referees who are in a position to comment on you professionally, with a brief indication of how long and in what capacity they have known you (referees will not be contacted without your prior agreement).
